WHAT HAPPENED AT THE LAST BOARD OF EDUCATION MEETING?

The Board of Education met on Monday, June 10th, 2013 at Arbor Park Intermediate School for a Work Session and regular board meeting. Qualified Capital Purpose Undertaking Fund:

Supplemental Salaries:

The Board of Education approved a motion to approve the supplemental salaries for the 2013-14 school year.
